

## **WMV and Supplemental Food**

- One of the 7 Wildlife Management Practices
- Texas Wildlife Tax Valuation law allows landowners to qualify in the Supplemental Food category by supplying their target species with a dedicated source of food





## Why is it Important?

- Excellent method of attracting wildlife
  - Improving food distribution increases the amount of usable space for wildlife
- Reduced pressure means healthier wildlife populations
- The more vulnerable your target species the more important it becomes
- Wildlife as a crop...





## What Does Not Qualify?

- Timed feeders technically do not
- Corn is a bait not a supplement
- Unreliable, poorly maintained sources that are non-functional or not maintained
- Food that is not meant specifically for wildlife

- Feeders and mineral supplementation
- Food plots
- Strip discing
- Range enhancement
- Reseeding

#### Requirements

- Must be a supplement and needs to be free choice
- Installation of new supplemental food sources or new food projects – feeders and food plots
- Maintenance of existing sources also qualifies
  Use what you have!
- Density requirement for food sources
  - One feeder per 320 acres in most cases
  - Food plots and discing = 10% of a designated or 10 acres, whichever is greater





## Timing

- Deer- protein May- Aug, corn only as needed for hunting season
- Wild Turkey and songbirds grains year round or winter/summer, avoid March-August within 300 ft of endangered species habitat to discourage cowbirds. Protein (dried peas, beans) during spring if desired or if insects low for nesting.
- Food plots
  - Warm- season plant March-May
  - Cool Season plant Sept-Oct
- Reseeding
  - March-April or Sept-Oct. fall is best for native grasses, especially this fall with El Niño coming
- Discing
  - Dec-Feb. different timing will generate different plants so varying time and location is important for diversity.
